## GENERAL RENTAL CONDITIONS

### 1- Object of the contract

The rental of a bicycle with or without accessories, equipped with the basic equipment provided by NAI'A VILLAGE, hereinafter referred to as "the renter".

The bicycle, its accessories and its basic equipment leased hereunder, taken alone or collectively, are designated, "rented property".

### 2- Basic equipment of the bicycle

Each rented bicycle is equipped with front and rear lights, lock, front basket (for adult bicycles, except Vertigo model), and helmet.

### 3- Terms of Use

The leaser certifies that he is able to use the rented property and declares that he does not have any medical condition. A responsible adult must accompany any underage person.

The leaser agrees to use the rented property himself. The loan or sublease of the rented property is strictly prohibited.

The leaser cannot intervene on the rented property in case of breakdown without the agreement of the renter.

The leaser promises to use the rented properties for a leisure purpose only, as a "good family father", and will not use them dangerously, for himself nor a third party.

The leaser is the custodian of the rented properties and remains responsible for their use, both in regards of the leased property themselves and third parties.

The leaser agrees to observe the road regulation rules at all time.

The use of the helmet is compulsory for those under 12 years old (Article R431-1-3 of the French Road Code), the renter cannot be held responsible instead of the leaser in the event of the non-compliance to this rule.

The leaser admits that the renter loaned him a helmet.

During the parking of the bicycle, it is compulsory to use the lock.

Bicycles: Their use is forbidden to anyone weighting above 115kg.

Luggage carriers: Their use is strictly limited to the object with a small volume and not exceeding 27kg. It can never be used to transport people.

Kids seat: Their use is limited to kids between 2 and 5 years old which weight is between 8kg and 18kg. The kids must be correctly buckled by using the belts provided for this purpose

Kids trailers: Their use is limited to 2 kids aging between 2 and 6 years old. The total weight (2 kids) cannot exceed 40kg, or 25kg (1 kid).

### 4 - Start the contract, receive and return the rented equipment

The leasing comes into force when the leaser takes possession of the rented properties delivered to him.

This contract applies only for the duration of the lease. If the leaser keeps the rented properties longer than the agreed duration, without having extended his contract, he loses all the benefit guaranteed by the contract.

The leaser acknowledges having received the rented properties in good working condition and with the basic equipment.

The leaser states that has all the necessary abilities to verify the condition of the rented properties and choose them in accordance with his needs.

The leaser agrees to return the rented properties in the state in which he rented them, except for normal wear.

### 5 - Payment and payment methods

The entire rented package must be paid by the leaser as soon as the contract is concluded, in case of the rented properties are taken immediately by the leaser.

Accepted payment methods are: credit card, holiday vouchers, cashless and cash.

No matter the payment method, the deposit must be given when the rented properties are taken.

### 6- Booking and cancellation

Every booking or cancellation must be made at the front desk of NAI'A VILLAGE.

### 7- Responsibility in case of accident, damaged or stolen rented properties

The leaser discharges NAI'A Village from any liability arising out of the use of the rented properties within NAI'A Village or not, especially in case of physical or psychological consequence, as well as equipment damages resulting of an accident of any nature.

The leaser claims to be the holder of a personal liability insurance which guarantees the liability incurred in connection with the use of the leased properties by himself, the persons he has custody of.

The leaser has no coverage for the damage or theft suffered by the rented properties and personally commits liability for the said damage, breakage and theft. Damage to the rented properties, theft or loss of the rented properties will be charged to the tenant in accordance with the applicable costs set out below, refer to the "Part and price list of damaged parts".

### 8- Deposit

Once the rented properties are taken by the leaser, the leaser must pay the deposit (by credit card, bank cheque or cash).

The amount of the deposits is 400€ per bicycle.

This deposit is not collected from the bank account, and the cash is kept during the rental period stipulated in the contract. Once the rented properties are returned to the renter, and the good condition of the rented properties is confirmed, the deposit is returned.

The leaser authorizes the renter to collect from the deposit the due amounts in the following events:

The insurance needs to be used, a franchise will have to be paid

To repair or replace the rented properties, in accordance with the "Part and price list of damaged parts" below

As a compensation for giving back the rented properties later than agreed in the contract

It is expressly agreed that the amount of the deposit cannot under any circumstances constitute a limit of guarantee, the renter retaining, where appropriate, the right to prosecute the leaser in order to obtain the whole compensation for his damage.

#### **9- Return the rented properties**

The return of the rented properties shall be made at the time stipulated in the contract. In addition, the leaser must be informed that:

For half-day rentals, rented properties must be returned before 1:00 PM or before 6:30 PM depending on whether the contract starts in the morning or the afternoon.

For daily Rentals, the rented properties must be returned before 6:30 PM.

Any late return will result in the application of a lump sum penalty equal to the one-day rental rate per half-day or one-day delay.

#### **10- Prohibition of loan or sub loan**

The leased properties can not be sold, nor sent to warranty. The leaser agrees not to consent in regard of the leased properties any right, real or otherwise, to the benefit of any person who may affect its enjoyment or to limit the availability or full ownership of the renter.

#### **11- Disputes**

In the event of any dispute relating to the execution, interpretation or termination of this contract, the competent court shall be the one where the head quarter of the renter is registered, court to which the parties assign exclusive authority and competence.
